Safeguarding the Constitution

LGBT RIGHTS – EXPANDING BENEFITS FOR DOMESTIC PARTNERS

Although many domestic partners still lack the legal protections and benefits that married couples take for granted, ACLU-NM secured expanded protections for retired state employees and ensured benefits for the families of future retirees.



RACIAL JUSTICE – PROTESTING RACIAL DISCRIMINATION

In the fall of 2009, the Whitten Inn in Taos fired several employees for speaking Spanish and refusing to anglicize their names. Since speaking Spanish did not interfere with the essential functions of the employees' duties, their termination appears to be illegal. ACLU-NM joined the community in protest, speaking out against discrimination in the workplace based on race and national origin.

CORRECTION REFORM – PROTECTING PRISONERS FROM ABUSE

During a disturbance in another part of the prison, guards at the Northeast New Mexico Detention Center in Clayton locked seven nearly naked inmates in a shower, then videotaped them. After five hours, the inmates were forced to crawl through a small, filthy hole in the wall to return to their cells. ACLU-NM filed suit in June 2009 alleging that the treatment of these prisoners was cruel and unusual.



CORRECTION REFORM – PROTECTING YOUTH

Over 1,500 youth who are cared for in state facilities each year will be safer and receive better treatment because of ACLU-NM. After six years of hard work, our cooperating attorneys forged an agreement with the NM Children Youth and Families Department (CYFD) that secured substantial improvements to essential health and safety services for youth in custody.

POLICE PRACTICES – ENSURING PROPER OVERSIGHT

Following pervasive reports of alleged police misconduct in Las Vegas, ACLU-NM organized a series of public meetings with local officials to air the community's growing concerns and educate about civil rights complaint procedures. As a result, local citizens created a police oversight committee to investigate claims of rights violations and ensure that local law enforcement remains accountable to the community and the constitution.

LGBT RIGHTS – FIGHTING FOR EQUALITY

Once again, ACLU-NM stood at the forefront of the movement for LGBT relationship equality. In both 2010 legislative sessions, we lobbied for the Domestic Partnership Rights and Responsibilities Act, which would provide crucial legal protections to domestic partners and their families. Though this legislation failed to pass, ACLU-NM continues to build support for LGBT rights.



FREE SPEECH – DEFENDING THE RIGHT TO PROTEST

On the eve of the U.S. invasion of Iraq in 2003, thousands of Albuquerque citizens took to the streets to exercise their 1st Amendment right to disagree with the actions of the government. This peaceful protest was met with tear gas, batons, rubber bullets and numerous arrests. ACLU-NM represented 13 of the protesters who sued the Albuquerque Police Department for unlawfully suppressing their right to free speech. Although we did not win the case, ACLU-NM and the protesters sent a strong message to law enforcement throughout the state that violations of free speech will not go unchallenged.

LGBT RIGHTS – SUPPORTING PRIDE IN GALLUP

Along with several other advocacy groups, ACLU-NM helped launch Gallup's first annual LGBT PRIDE celebration last summer. PRIDE celebrations raise awareness about important civil rights challenges facing the LGBT community and build support among the public for equality for all.



FREE SPEECH – RESTORING ACCESS TO PUBLIC LIBRARIES

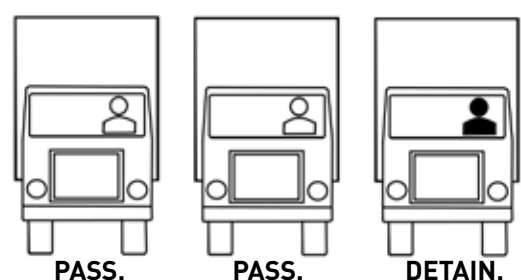
When the City of Albuquerque adopted a controversial regulation that banned all registered sex offenders from the city's public libraries, ACLU-NM immediately filed a complaint. This unconstitutional action restricted the 1st Amendment right to receive information. The federal court agreed and struck down the regulation in March 2010, ruling that it was an overly broad suppression of constitutional rights that did not address a narrowly defined public safety need.

IMMIGRANTS' RIGHTS - ADVOCATING FOR PUBLIC SAFETY

ACLU-NM Regional Center for Border Rights is working with local religious and community leaders to convince the Roswell City Council to adopt a policy that prohibits local police from enforcing federal immigration law. This agreement would increase public safety by focusing resources on local crime prevention.

FREE SPEECH – STRIKING DOWN CENSORSHIP

Usually citizens can air their concerns and grievances about local government actions during the public comments portion of a municipal commission meeting. However, in late 2009, Valencia County and Truth or Consequences began to censor speech during their meetings. The ACLU-NM legal team stepped in and restored full free speech rights.



RACIAL JUSTICE – CHALLENGING RACIAL PROFILING

Curtis Blackwell, an African-American long-haul truck-driver, was pulled over at the Lordsburg Point of Entry in August 2008. On inspection, officers found unopened alcohol in an outside compartment of his truck and falsely accused Blackwell of being under the influence. ACLU-NM investigated and found a clear and consistent pattern of racial profiling. We filed suit against the NM Department of Safety for targeting drivers for inspection solely on the basis of race.

CORRECTION REFORM – WINNING MENTAL HEALTH TREATMENT

ACLU-NM achieved a major victory this February when we secured vital mental health services for the 800 detainees housed in the Doña Ana County Detention Center in Las Cruces. Under the terms of the settlement, detainees will receive standard mental health screenings and improved treatment from better trained staff.



IMMIGRANTS' RIGHTS – EMPOWERING IMMIGRANT COMMUNITIES

ACLU-NM Regional Center for Border Rights offered 17 "Know Your Rights" presentations for over 300 immigrant community members throughout southern New Mexico in the past year. These presentations provide the tools and information people need to defend their rights when stopped by law enforcement and to develop a family safety plan in the event of arrest, detention or deportation.

IMMIGRANTS' RIGHTS – FREEING IMMIGRANTS FROM ILLEGAL DETENTION

The U.S. Supreme Court ruled that immigrant detainees cannot be held for more than six months after a final deportation order is issued even if their country of origin will not allow their return. Yet hundreds of detainees languish indefinitely in illegal detention. Using Habeas Corpus petitions, ACLU-NM secured the release of 22 men from the Otero County Processing Center in the last year. Since 2006, we've freed more than 80 people who were illegally detained.

ACLU-NM has a goal: to instill in every lawmaker, every government decision-maker, in every corner of New Mexico, the instinct to consider, "How will the ACLU respond?" anytime they contemplate infringing on someone's rights. Before the Ruidoso police stop Hispanic motorists to check for immigration papers; or county commissioners in Los Lunas ban an outspoken neighborhood activist from their meetings; or a jailhouse warden denies female inmates their right to terminate unwanted pregnancies, we want those officials to think first of the Bill of Rights.

We're on our way to achieving this goal. For example, this year we discovered that four counties in southern New Mexico voluntarily adopted policies that prevent local sheriff's deputies from enforcing federal immigration laws because of a lawsuit we won against Otero County in 2008. In fact, unlike Arizona, most parts of the state have laws and policies that specifically safeguard the rights of immigrants, because over the years ACLU-NM has worked with local allies and government leaders to protect constitutional liberties for all.

ACLU-NM has a powerful and proactive statewide presence that will continue to strengthen in the years ahead. In counties and municipalities around New Mexico, the ACLU is becoming a household word. Over the last twelve months, we have improved the lives of thousands of New Mexicans—protecting the safety of children, securing benefits for LGBT families, striking down censorship, and releasing immigrants from illegal detention.
